Tour was to Jim and Sherri Ladd's where Patrick Toomey, NRCS Grazing Specialist, gave a presentation on Ladd's cow/calf grazing management project taking beans and corn out of production to help reduce nitrates in the wellhead areas. There was also a stop at Tom Fick's where speakers from the U of M gave presentations on the Forever Green Program including information on kernza and perennial wheat grass. Fick also spoke of his experience raising and marketing kernza.

Conservation Agronomist:

Bos stated the Conservation Agronomist, Paul Messner, resigned so the job has been posted with New Vision and on our Rock SWCD website. Bos asked the board to let us know if they hear of or know of anyone who might be interested.

NRCS Update:

Heard stated there has been some shifting in NRCS employees. Dylan Bartels resigned to take a job with NRCS in Iowa, Levi Campion resigned to take a job with NRCS in South Dakota. Nathan Blankers moved to the Pipestone office starting today. She stated tiling requests will be about a year behind because Jake from the Compliance Team in Marshall also resigned to pursue a job with Ducks Unlimited. She stated she will give the rest of her updates at the Local Work Group meeting following this meeting.
